We refer to:

- (a) the commitment letter dated the date hereof between the parties hereto (the “**Commitment Letter**”) and the Senior Unsecured Bridge Facility, the Term Sheet and the Refinancing Facilities Agreement referred to therein;
- (b) the Bridge Facilities Fee Letter referred to in the Commitment Letter;
- (c) the Interim Facility Fee Letter referred to in the Commitment Letter; and
- (d) the Refinancing Facilities Fee Letter referred to in the Commitment Letter.

The documents referred to in clauses (a) through (d) above are referred to herein as the “**Commitment Documents**.”

Capitalised terms used in this amendment letter, unless otherwise defined herein, shall have the meaning given to such terms in the Commitment Letter.

You have advised us that you intend to modify the longstop date for the Acquisition as set forth in Co-operation Agreement, and we have agreed to reflect the modified longstop date in the Commitment Documents.

The parties hereto agree to amend the definition of Longstop Date set forth or referred to in each of the Commitment Documents (including, for the avoidance of doubt, the forms of the Senior Unsecured Bridge Facility and the Term Sheet scheduled to the Commitment Letter) by replacing the reference in such definition to “31 May 2016” with “31 July 2016”.


