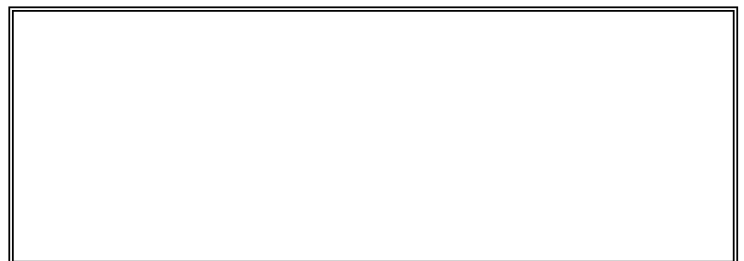

Unless the context requires otherwise the definitions in the Scheme Document also apply to this DTC Election Form.

- The DTC Participant will receive the shares as a Delivery Order ("DO") from CTCNA's DTC participant account #2415.
- If the nominated DTC Participant does not accept the DO after two attempts; the relevant New Liberty Global plc Shares to which you are entitled will, instead, be delivered to you either in the form of Liberty Global CDIs, or they will remain in the CTCNA Exchange Account which will hold those New Liberty Global plc Shares in the Liberty Global Facility and CTCNA (as Exchange Agent) will send, via post, to you a Letter of Transmittal "LT", typically within 5 business days of the Scheme Effective Date, to enable you to claim your New Liberty Global plc Shares from the Liberty Global Facility.
