PANAMA TELEMAMMOGRAPHY NETWORK WINS AWARD Cable & Wireless Panama wins GTB Innovation Award for social telecoms project

The first telemammography network in Latin America won the Mobile Health Innovation award at the Global Telecoms Business Innovation Awards.

The telemammography network was created by Cable & Wireless Communications' Panama business, Cable & Wireless Panama.

The project was launched in Panama in October 2010 to increase the number of women getting annual mammograms and reduce the time taken to diagnose scans. The telemammography network will particularly help many women in rural communities who did not have access to regular mammograms previously.

The system introduced digital mammograms in hospitals nationwide in order to reduce the cost of the service and reduce the diagnosis time. The digital mammograms can be sent securely between departments and to specialists based outside Panama. An automated workflow was also introduced, including radiology imaging, medical records management, statistics and cost control and a digital appointments system which sends automatic reminders to patients.

The Government of Panama commissioned the telemammography network because there are over 500,000 women in the country aged over 40, the most at risk group for this disease, but only 50,000 had annual screenings. Statistics indicate that one in nine women over 40 is likely to get breast cancer. The telemammography network is expected to increase the percentage of women aged over 40 getting annual mammograms from 10%-30%, helping an estimated 100,000 Panamanian women.
